LACLJ Sets Precedent for CA Survivors

Susana did not hesitate to call the police on the night her husband repeatedly threatened to kill her. **She feared for the emotional well-being of their children** who had already witnessed their dad physically abusing her earlier that night. After filing a police report, Susana obtained a criminal protective order against her husband that prohibited him from contacting Susana and their children.

However, **Susana was denied another key legal protection** (known as a domestic violence restraining order) that offers a wider array of critical protections to survivors, such as child custody and visitation orders. Without this additional legal protection, Susana's husband could cancel the criminal order or take away her children at any time. Susana didn't want to **risk her children's safety** so she came to LACLJ to learn about her rights as a survivor of domestic violence.

With the help of pro bono attorneys from Sidley Austin LLP and Gibson, Dunn & Crutcher LLP, LACLJ successfully overturned the Court's decision that originally denied Susana's request for a domestic violence restraining order. The [published decision](#) that resulted from the appeal will **ensure that survivors in California**

can obtain the necessary legal protections to maximize their safety. For Susana, this decision means she can now look forward to rebuilding her life with her children in a **violence-free** home.



Earlier this month, **LACLJ volunteer and Leadership Council member, Martin Kohan** (second from the left in the picture above), was presented with The Legal Aid Association of California's 2019 Award of Merit in recognition for his work on behalf of low-income immigrant survivors of domestic violence and sexual assault.

Immigrant survivors of a crime who cooperate in the prosecution of their abusers can petition for certain types of immigration relief available to them as victims of a crime, such as a U-Visa or VAWA. Martin has drafted such immigration petitions on behalf of hundreds of immigrant survivors, many of whom have already obtained a work permit or green card because of his work.

Martin's commitment to the agency goes beyond client representation. He joined LACLJ's Leadership Council last fall and has leveraged his personal network to raise funds for LACLJ during the agency's annual Domestic Violence Awareness Month Campaign.

Congratulations on this well-deserved honor, Martin!
