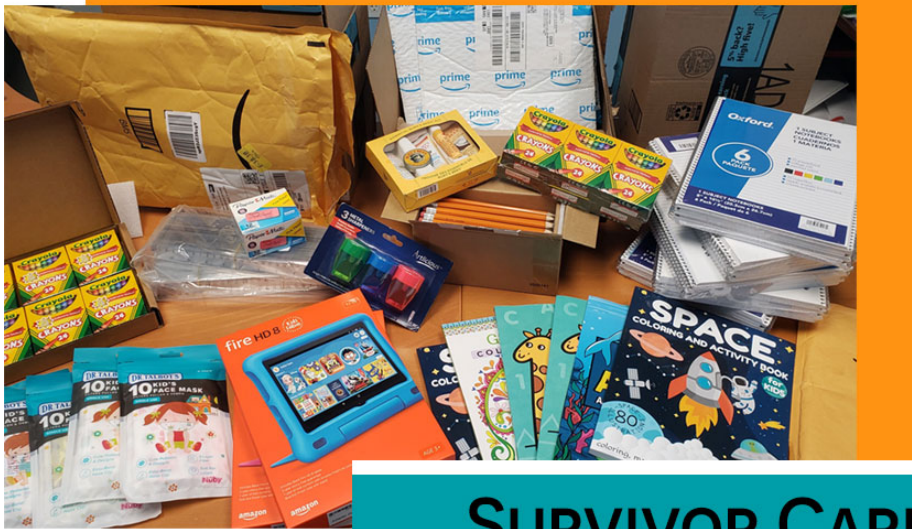

## COLLIN P. WEDEL, J.D.

### **Why did you join the LACLJ Board?**

I believe strongly in LACLJ's mission of empowering survivors of domestic violence and giving them a voice in the justice system. It is unfortunate that most people have been impacted by domestic violence or sexual assault in some way. I am proud to be part of an organization that is doing something about it.

### **What has struck you the most in your year of Board service?**

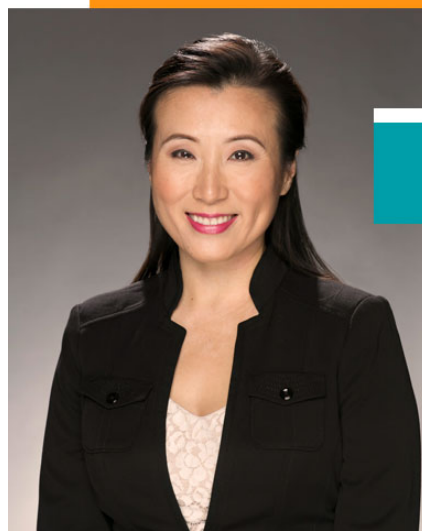
It has been eye-opening to learn how many lives are impacted by domestic violence and sexual assault, and how wide-ranging and long-lasting the legal, personal, professional, familial, and communal consequences can be. It is even more shocking how few resources exist to help survivors navigate that thicket.

### **LACLJ has a long partnership with your firm, Sidley Austin. How has their commitment to community service impacted you?**

Being at a firm, like Sidley Austin, that values pro bono work and meaningful community investment means everything to me. There is so much unmet need for legal services, and it is essential that the legal profession do its utmost to meet those needs. Sidley lives up to that calling, and has encouraged me to maintain a robust pro bono practice throughout my career at the firm.

I have done a lot of pro bono work in the capital punishment space and I am currently on a team representing a survivor before the California Supreme Court. We are arguing that domestic violence survivors do not automatically waive their litigation rights when they resolve restraining order disputes through mediated agreements. The experience has been deeply meaningful and challenging.
